Dear Intended Parent(s),

Thank you for your inquiry regarding our agency and ovum donorship services. This letter is for information only and is not a contract.

We will match any other free standing (not a part of a fertility clinic) agency's administrative fees and expense reimbursement amounts to the egg donor.

Below is an **estimate** of our fees. **Fees are subject to change without notice. WE DO NOT ACCEPT CREDIT CARDS; Checks and money orders are fine.** A summary of the steps involved in screening and working with a donor follows the fee estimate.

One hour initial consultation by phone or in person.....Free

Facilitated meetings with 2 different donors at our office.....No administrative charge (Recipient pays for donor's travel costs and \$25 for her time in the meeting)

Donor's fee after retrieval\$7,500 - \$10,000 +/-

Donor's travel, childcare costs.....Up to \$700

Out-of-State Donor's travel, childcare costs\$5,000 or more

Psychological evaluation by licensed therapist \$350 (\$120 additional if your clinic requires personality testing)

Genetic Counseling for First Time Donors for IP's at Stanford.....\$300

Background check on donor (optional).....\$100

Administrative fee.....\$4,300 (\$4,800 for international clients or using a long distance donor)

AIG (accident insurance for donors). \$400

EXAMPLE OF TOTAL AMOUNT UPON EXECUTION OF CONTRACT

Donor fee \$7,500 - \$10,000 +/-

Donor costs \$700 or \$5,000 +

AIG Ins. \$400

Psych. Eval. \$350 - \$470

Admin. Fee \$4,300 or \$4,800 for International Recipients and Long Distance Donor

FEES BELOW ARE NON-REFUNDABLE ADVANCES ON ADMINISTRATIVE FEE

Subsequent phone/email consultations re egg donation prior to donor selection.....Hourly Rate
Selection of donor (covers administrative work of match with fertility clinic).....\$500
Advertising for unique donorcost of ad
Balance of Administrative Fee due for Drafting of Contract. \$3,800 (local) or \$4,300 (international or Out-of-State)

My protocol is as follows: advertise for donors, screen and educate regarding the procedure over the phone, analyze health history form, face-to-face interview with donor, coordinate donor’s psychological screening by a licensed mental health professional (interview and possibly PAI), if requested arrange meeting with donor and couple (on a first name basis), upon receipt of administrative fee contract is drafted , upon execution of contract and balance of fees collected donor is referred to IVF program for medical screening (blood testing for infectious diseases, physical exam, pap smear) and consultation, liaison with the couple, donor and IVF program until retrieval, donor is paid after retrieval. There are approximately forty donor applicants in my pool at varying stages of availability. New donor candidates come in to our pool on a weekly basis.

At your convenience, I would be happy to discuss further details of my practice with you. I hope that this information is useful and I look forward to working with you.

Directions to our Office

From San Francisco or the Richmond Bridge: 101 North to **Central San Rafael Exit**, right at light on to 2nd Street, which turns into San Pedro Road, stay on San Pedro Road for 5 miles, go past McNears Beach Park, left on Biscayne Drive, 1st left on Biscayne Court until #25, an off white house on the left.

From East Bay: Take I-580 West and cross the **Richmond San Rafael Bridge**. Stay on 580 east to 101 North take first exit (1/2 mile after getting on 101 N) Central San Rafael Exit. (Follow directions above to #25 Biscayne Court) **From Santa Rosa:** 101 South to Central San Rafael Exit, left at last light on to 2nd St., which turns into 3rd St. and then into San Pedro Rd., stay on San Pedro Rd. for 5 miles, go past McNears Beach Park, left on Biscayne Drive, 1st left on Biscayne Court until #25, an off white house behind Redwood trees on the left.

From San Jose or the Peninsula: Take I-280 North to 19th Street. Follow 19th Street through Golden Gate Park and the Presidio, through tunnel toward the Golden Gate Bridge (101 North). Take 101 North to **Central San Rafael Exit**, right at light on to 2nd Street, which turns into San Pedro Road, stay on San Pedro Road for 5 miles, go past McNears Beach Park, left on Biscayne Drive, 1st left on Biscayne Court until #25, an off white house on the left.
